### 1. Definitions:

**“Company”** means Brother International (M) Sdn Bhd

  - d. invoice file should not exceed 5MB
  - e. all package is guided with minimum recommended selling price, entries with lower than minimum advertised price would not be entitle for redemption.
  - f. all entries must be submitted online within 14 days upon purchase date.
